

TERMS AND CONDITIONS – CHECK PRESS

These Terms and Conditions govern the use of the **Check Press** mobile application, intended for recording blood pressure values voluntarily entered by the user (hereinafter “Application”).

1. Identification

The **Check Press** Application is owned by the Portuguese Society of Hypertension, with the support of the Tecnimede Group, and was developed by **Float Publicidade, Lda.**

2. Purpose

The Application is intended exclusively for recording and storing accurate blood pressure readings altered by the user, and does not, under any circumstances, alter medical advice, diagnosis or treatment.

3. Conditions of Use

Use of the Application is conditional upon full access to these Terms and Conditions.

The **Check Press** Application is not intended for minors. Only users aged 18 or older may create an account and use the Application.

The user agrees to provide truthful information and maintain the confidentiality of their access credentials.

4. Responsibility

The Application is for informational and recording purposes only. **Float Publicidade, Lda.** does not guarantee the accuracy, integrity, or timeliness of the data entered by the user, nor is it responsible for any decisions, actions, or omissions based on the information recorded in the Application.

The user should always consult a qualified healthcare professional.

5. Scientific Basis

All tips, medical recommendations, and blood pressure value classification criteria used in the Application are based on internationally recognized clinical guidelines, validated by the Portuguese Society of Hypertension, namely:
